# Proposed Platform Adopted by the Drafting Committee on July 29, 2023

#### Preamble

The California Republican Party envisions a vibrant, prosperous, and safe California defined by a robust world-class economy, strong and healthy families, responsive state and local governments that serve all people while protecting individual liberties as enshrined in the US Constitution and our sovereignty as a Nation under God, our Creator. As the party of Abraham Lincoln, we believe in dignity and equality for all.

With Republican principles, we are boldly confident about restoring and improving California's future and hold dearly all that is good about California's citizens.

**Public Safety and Criminal Justice:** Our commitment to a safe, peaceful, and law-abiding California is unwavering. We believe in ensuring public safety under the rule of law. We understand that effective law enforcement requires collaboration, transparency, and accountability. We support surety bail and oppose same day release of persons charged with serious crimes without reasonable bail. We also value those rehabilitation and reentry programs that lower recidivism rates. We support funding law enforcement.

**Economic Development:** We believe in the power of a free and open market as the engine of prosperity. Recognizing California's entrepreneurial spirit, we champion policies that reduce burdensome regulation and taxes, creating a more favorable business climate. We uphold the principle that individuals are the ultimate creators of economic opportunity and wealth. We envision opportunities for Californians to succeed and prosper in a thriving economy.

**Homelessness:** Addressing homelessness compassionately and effectively is a priority. We believe in a multifaceted approach that combines personal responsibility, community support, mental health resources, and addiction services. We stress the importance of transitional programs, including job training and placement, to help individuals move from the streets to stable living situations.

**Housing:** We recognize the importance of affordable and accessible housing for all Californians. We support policies that encourage private sector investment and market- driven solutions, reducing government red tape that often inhibits housing development. We believe in empowering local communities to shape their housing landscapes while encouraging responsible growth and development. We support Proposition 13 (1978).

**Education:** We hold firm in our belief that all children, regardless of their background, deserve a quality education. We believe that competition and innovation, involving public, charter, private, and home schools, can drive educational excellence, preparing California's youth for a competitive 21st-century workforce. The parent-child relationship must be respected with parents/caregivers in control of every decision made regarding their child. We support a state constitutional amendment for school choice.

1101. No employer shall make, adopt, or enforce any rule, regulation, or policy:

(b) Controlling or directing, or tending to control or direct the political activities or affiliations of employees."

1102. No employer shall coerce or influence or attempt to coerce or influence his employees through or by means of threat of discharge or loss of employment to adopt or follow or refrain from adopting or following any particular course or line of political action or political activity.

There has been a push for employers to force their employees to use preferred gender pronouns. This has been ruled unconstitutional in Taking Offense v. State of California, but it's not clear if that ruling will hold or if legislation will try to get around it. However, by taking an opposing stand to the California Democrats on gender, an employee has more ammunition to raise the legal issue that the employer is "directing political activities or affiliations". That is, if they force an Republican employee to use preferred gender pronouns against their will, the employee can claim that such an action is unlawful, as it would be directing the employee's political affiliation to that of the Democratic Party. And unlike a free speech violation, a violation of sections 1101-1102 could result in fines, or up to one year in prison (see section 1103). Even the threat of a 1101-1102 violation could persuade employers not to trample on their employee's rights.

- Parents Rights are Civil Rights Support parent rights to their own children. Parents have a voice and we should support that voice. No hidden curricula. No hidden transitioning. No CRT no DEL. And support of Vouchers vouchers. It's all about choice, for parents.
- Defend Marriage as a religious institution Gov out of Religion See Paragraph below.
- Abortion SCOTUS has spoken. The Dobbs decision makes it clear. Personal medical decisions shall be made at the state and local level, or by the people.

CAGOP supports some time limitations on abortions. Is 20 weeks reasonable because at that point mothers can test to see if the fetus is in good shape, not retarded, not deficient.. These are reasonable time frames. And can the CAGOP ask to stop aborting term babies? It would seem most normal women would agree with this theory. Is that asking too much?

School choice is a civil right. And a decent public education is every parent's right, not the teachers unions cash cow. Parents are the basis for western civilization and parents rights are fundamental rights. You do own your children, in spite of what certain groups may say. I will introduce legislation that guarantees parents rights.

Parents 1st amendment rights to speak at any place, anytime to any school officials and to have a redress of grievances to any school board or officials. I will legislate to stop the social engineering. And to guarantee vouchers to every citizen parent for all Federal school expenditures. Also to outlaw porn in schools, no CRT race training, no DEI anti America anti family training in any school that receives federal funding.

Ballot Integrity Ballot integrity is the founding principle of our nation. Free and fair elections are an absolute necessity to our Republican form of government. I will introduce legislation that ensures any and all ballot and voting fraud cases are heard in Federal courts. Where evidence will be introduced, investigated, weighed and made public.

Further legislation shall make certain that voting is secure within the states by requiring; Ballots be on paper only, with a barcode on the ballot, with a precinct verified signature on the ballot, not on some thrown away sleeve. No truckloads of unverified ballots showing up at midnight.

No hidden suitcases of unverified ballots being run through machines dozens of times by unwatched election officials.

No paid mules dropping off thousands of unverified ballots to multiple unsecured drop boxes all over the nation. The answer is no. Marriage is a religious construct that stretches back over 6,000 years or more into all human history. The nuclear family is as basic as any institution in civilization. Today the government has taken over marriage. And the government has no right or business interfering with religious marriage - That between a man and a woman. Therefore Cole will propose legislation and court proceedings that seek to remove the government from traditional religious marriage. Government should stay the hell out of religion. Let the government issue a "Statement of Union" to gay or lesbian couples that wish a legal union.

And soon the government can deal with the thorny issue of two men, a woman and a goat... who demand their rights to a "Statement of Union". The basic problem with a government that has no moral background, is that even atheists and religion free government, are bound like it or not by morals based on our religious traditions. So get the government out of religion, as religion has been excised from the government.
