## **Resolution #1: Supporting President Trump's Agenda 47**

**Committee Action: APPROVED AS AMENDED**

WHEREAS, the Agenda 47 short videos produced by President Donald Trump's campaign and posted on his website detail powerful, optimistic policy solutions on energy, education, health care, restoring justice in the justice department, opposing government t censureship, fighting drug trafficking, crime and homelessness, increasing border security, trade, strengthening working families, expanding the space program, implementing defensive missile systems, and preventing World War III; and

**Resolution #3: Protect our Children**

**Committee Action: APPROVED AS AMENDED**

WHEREAS, the practice of gender-affirming care for minors, including the administration of puberty blockers and surgical procedures, has raised concerns regarding child welfare and medical ethics; and

WHEREAS, there are allegations of children being influenced to believe they were born in the wrong body and subjected to treatments without fully informed consent; and

WHEREAS, there is a growing need to protect minors from potential harm and ensure their rights to bodily autonomy and well-being are upheld; now

WHEREAS, school curriculums pushing radical teaching, gender neutrality, or any other age-inappropriate lesson plans foisted on parents with children in California's taxpayer funded public schools; and

WHEREAS, so-called "progressive ideologies" espoused by the left are hostile to religious and family values; and

WHEREAS, current policy in California allows transgendered biological male student athletes to participate in women's team sporting competitions; now

THEREFORE, BE IT RESOLVED, the CAGOP advocates for the enactment of legislation prohibiting the practice of child sexual mutilation; and
