The proxy is not valid unless dues are paid by both the appointing delegate (proxy giver) and the designated proxy (proxy holder). **Please closely review the checklist below to ensure your proxy form is not invalidated (see specifically #1, #2, and #3).**

### IMPORTANT CHECK LIST BELOW

**Proxy form must be received no later than noon on Saturday, March 15, 2025, at the Proxies & Credentials Desk. Proxies received after noon on Saturday will not be accepted.**

1. Only original signatures are acceptable. Copies of signatures such as a facsimile or photocopy will be rejected.
2. In order to prevent changes to the proxy giver or proxy holder after the form is signed, cross-outs or white-outs in the proxy giver name or proxy holder name sections will not be accepted. Corrections to addresses on the form are acceptable.
3. In an effort to confirm the identity of the proxy giver, the address of the proxy giver must match the address the CRP has on file, or staff must be able to confirm the address is the current registered voting address of the proxy giver.
4. Only voting Delegates or Associate Delegates in good standing may be proxy holders.
5. A maximum of two proxies may be held by a Delegate or Associate Delegate.
6. The proxy holder must be registered for convention in order to carry a proxy and be eligible to vote on any issue at the convention's General Session.
7. Dues of both the proxy giver and the proxy holder must be paid by 8:00 p.m. on Saturday, March 15, 2025, before the proxy can be deemed valid.
8. In order to vote on Sunday, all proxy holders must pick up their official Proxy Badge(s) at the Proxies & Credentials Desk on Sunday, March 16, 2025. Photo ID will be required to pick up the Proxy Badge.
9. If a Delegate giving a proxy is registered at the convention, the Delegate's Badge must be surrendered to the proxy desk. If the registered Delegate's Badge is not surrendered to the proxy desk, the designated proxy holder will not be able to pick up that Delegate's proxy. If the registered Delegate wishes to stay at convention and attend General Session after surrendering his/her Delegate Badge, a replacement Guest Badge may be issued.
10. Where more than one proxy is given by a Delegate, the one dated subsequently shall be given effect over the one dated earlier.
11. A proxy may be revoked only in writing under penalty of perjury. A notice to revoke a proxy must include the name of the person whose proxy is revoked (proxy holder), the date the proxy was given, and the name of any person or agent to whom the proxy form was given. The notice must be submitted to the proxy desk no later than 12:00pm on Saturday, March 15<sup>th</sup>.
